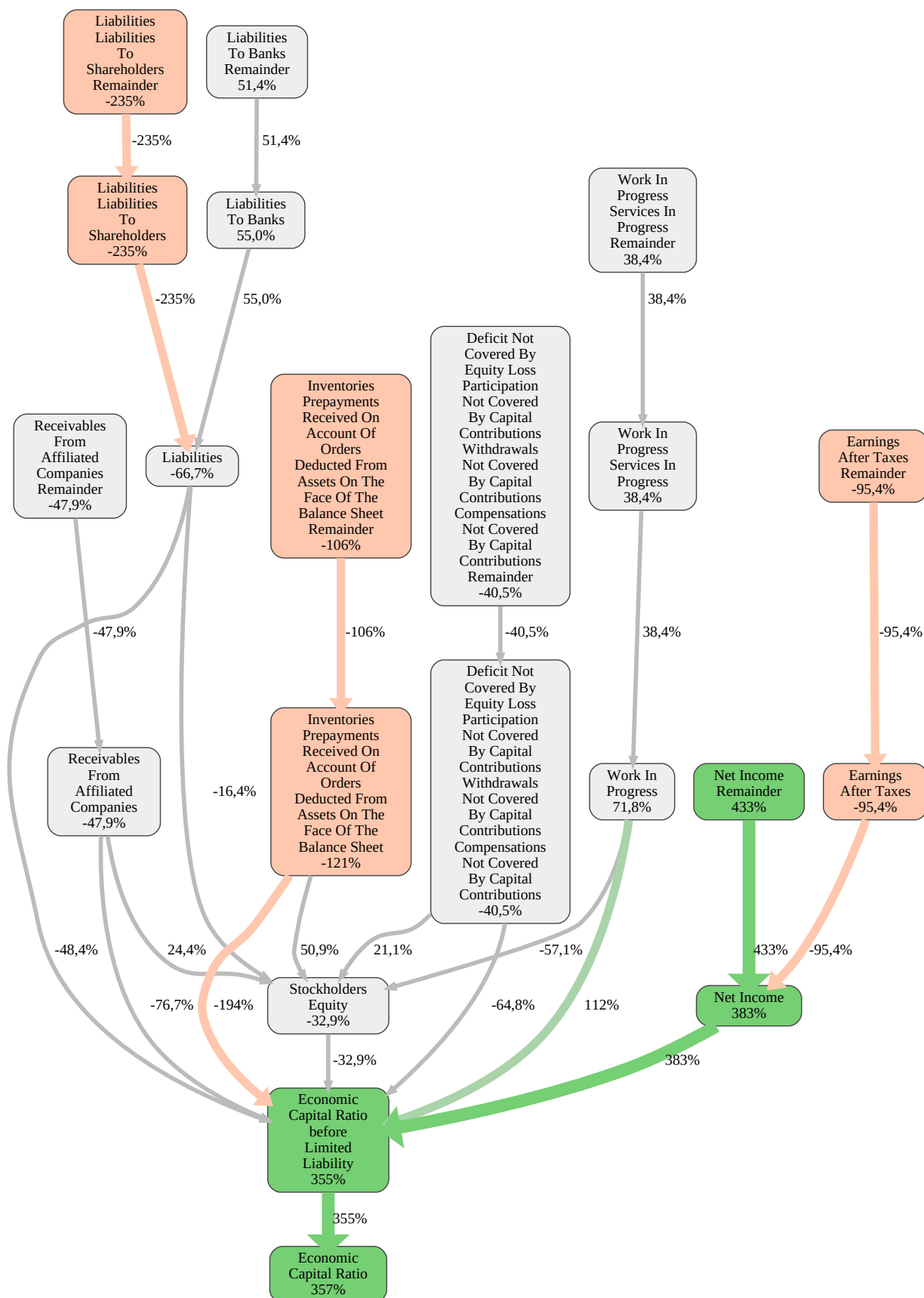




The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 433% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Liabilities To Shareholders Remainder, reducing the Economic Capital Ratio by 235% points.

The company's Economic Capital Ratio, given in the ranking table, is 539%, being 357% points above the market average of 182%.
