

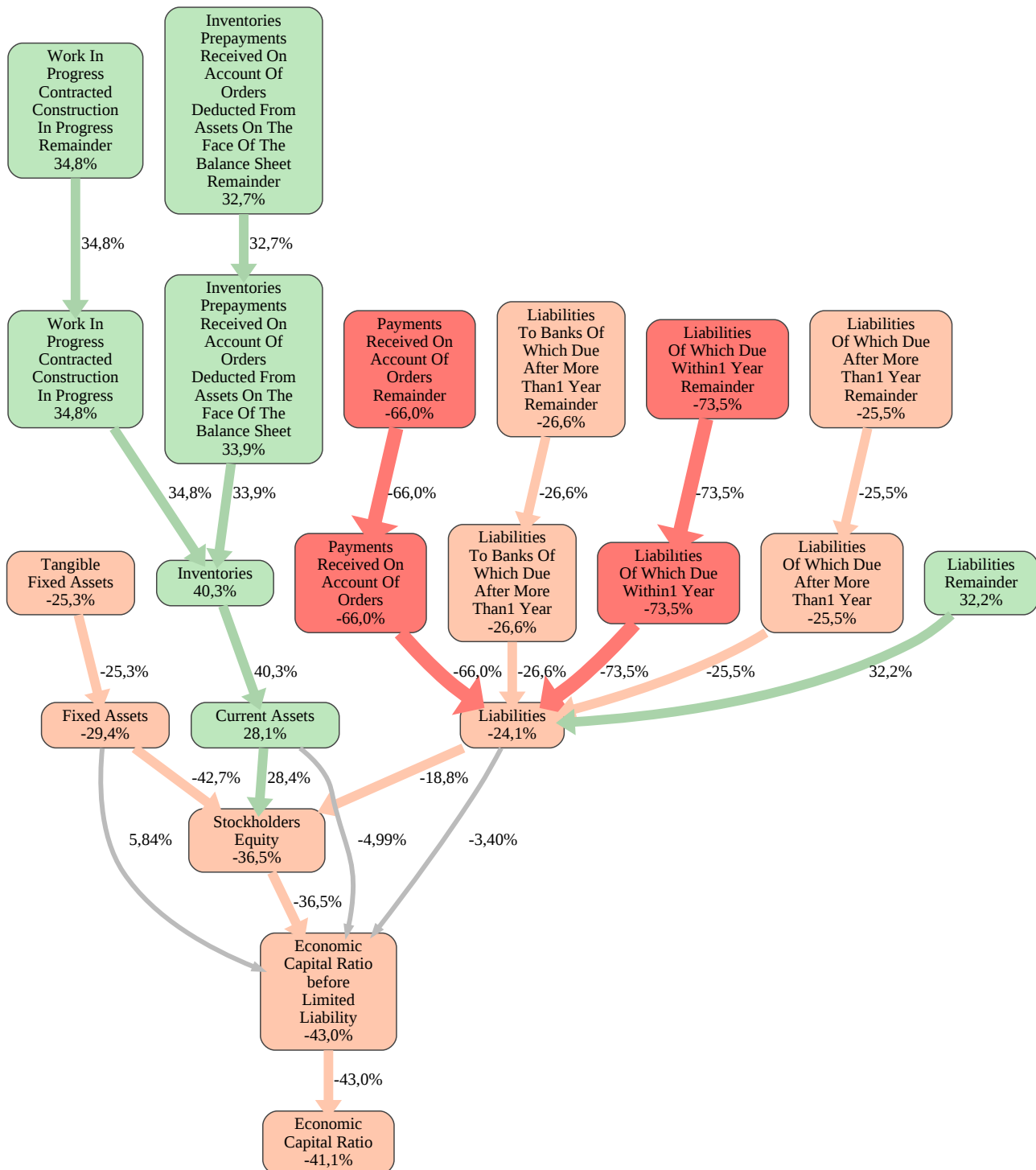

The relative strengths and weaknesses of Monte Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Monte Hochbau GmbH is the variable Liabilities Of Which Due Within 1 Year Remainder, reducing the Economic Capital Ratio by 74% points.

The company's Economic Capital Ratio, given in the ranking table, is 141%, being 41% points below the market average of 182%.
