

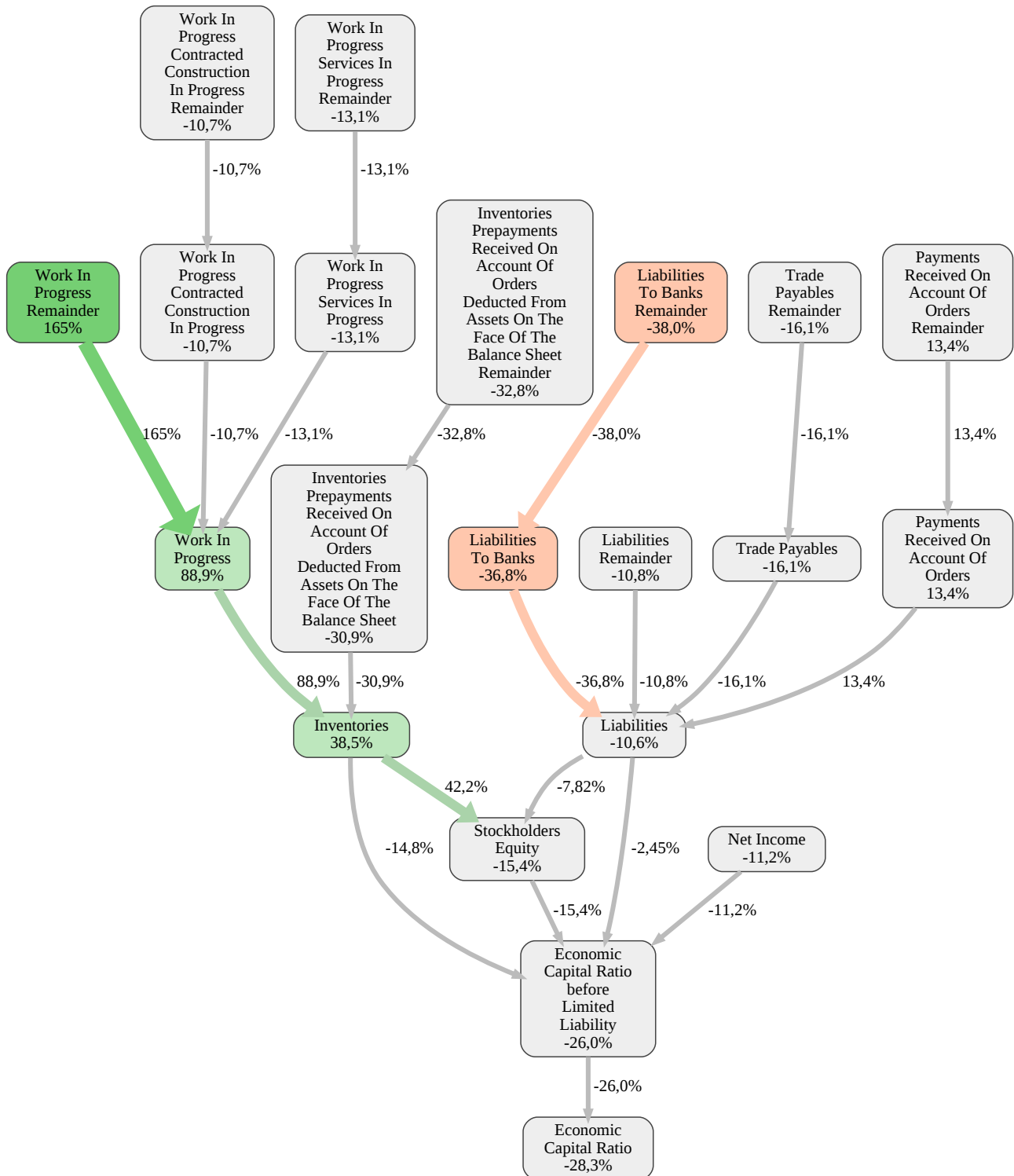

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 165% points. The greatest weakness of BMS Industriebau GmbH is the variable Liabilities To Banks Remainder, reducing the Economic Capital Ratio by 38% points.

The company's Economic Capital Ratio, given in the ranking table, is 165%, being 28% points below the market average of 194%.
