

Westdeutsche Rohbau Technik GmbH Rank 66 of 116

The relative strengths and weaknesses of Westdeutsche Rohbau Technik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Westdeutsche Rohbau Technik GmbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Westdeutsche Rohbau Technik GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 113% points.

The company's Economic Capital Ratio, given in the ranking table, is 174%, being 20% points below the market average of 194%.
