

Bateg GmbH Rank 31 of 116

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 205% points. The greatest weakness of Bateg GmbH is the variable Work In Progress Services In Progress Remainder, reducing the Economic Capital Ratio by 336% points.

The company's Economic Capital Ratio, given in the ranking table, is 205%, being 12% points above the market average of 194%.
