

Fuchs Bau GmbH Rank 43 of 116

The relative strengths and weaknesses of Fuchs Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fuchs Bau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 160% points. The greatest weakness of Fuchs Bau GmbH is the variable Work In Progress Contracted Construction In Progress Remainder, reducing the Economic Capital Ratio by 688% points.

The company's Economic Capital Ratio, given in the ranking table, is 196%, being 2,6% points above the market average of 194%.
