

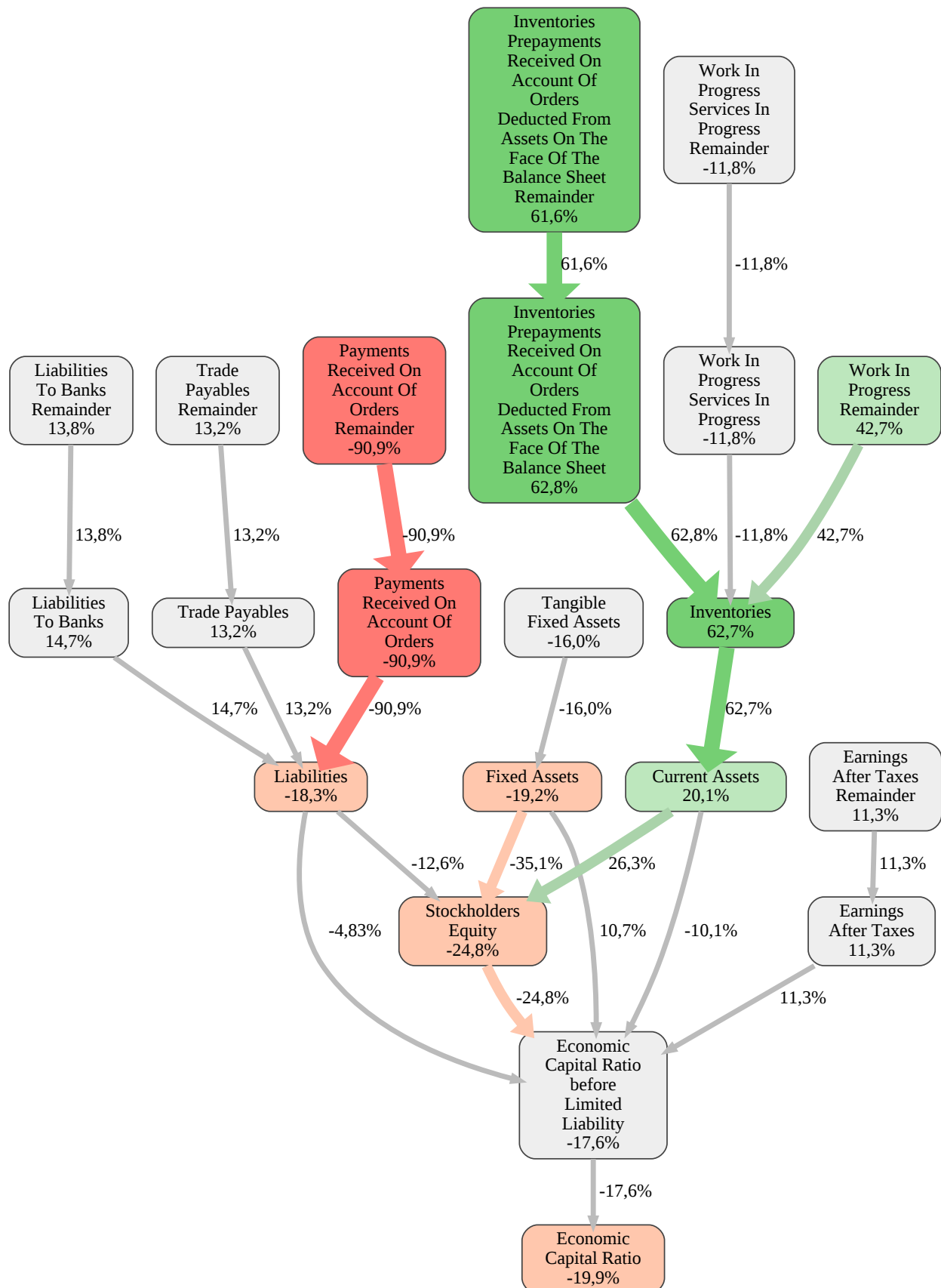

The relative strengths and weaknesses of Bauunternehmung Peter Igl GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 91% points.

The company's Economic Capital Ratio, given in the ranking table, is 174%, being 20% points below the market average of 194%.
