

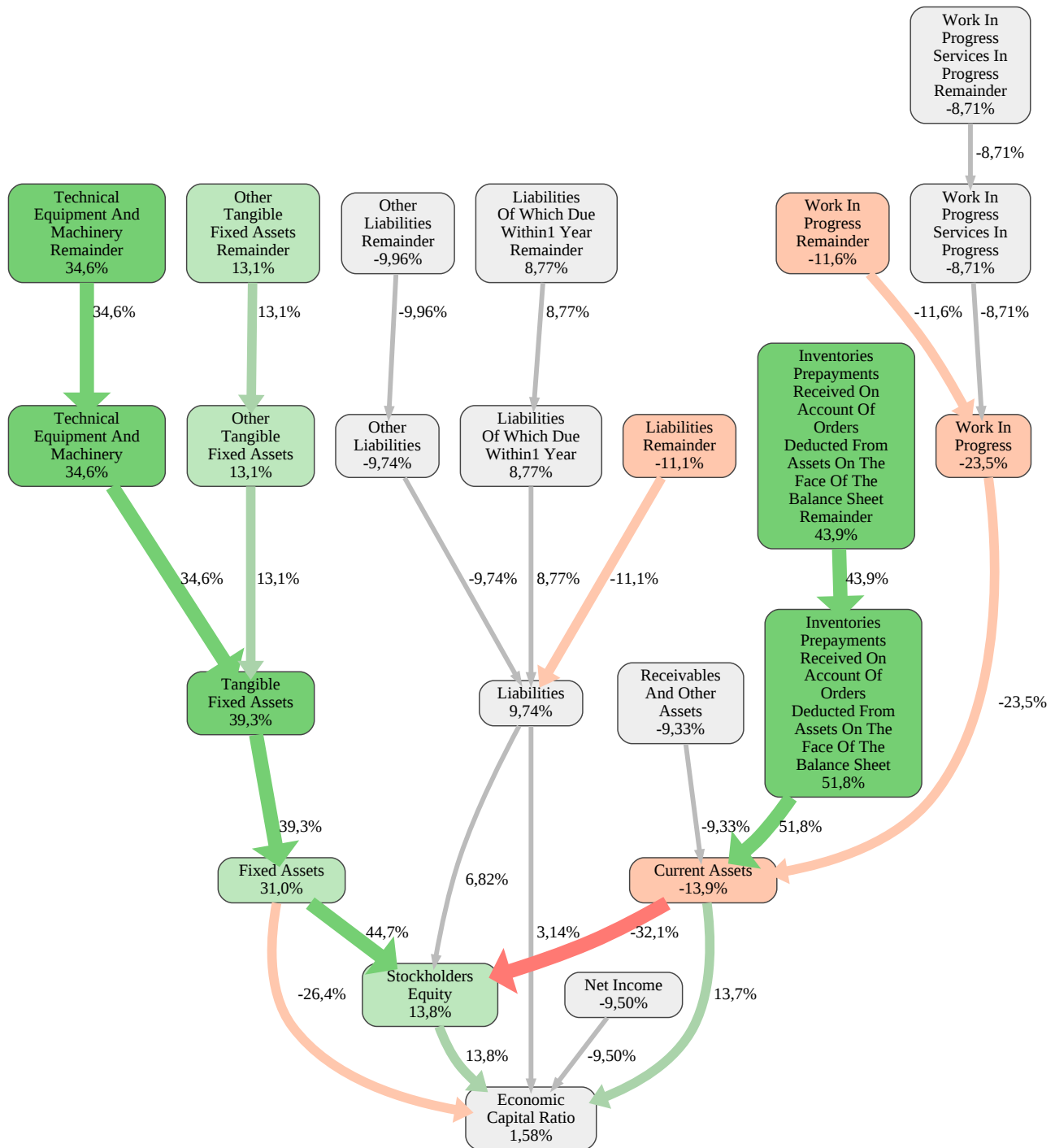

The relative strengths and weaknesses of Arlt Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arlt Bauunternehmen GmbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Arlt Bauunternehmen GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 23% points.

The company's Economic Capital Ratio, given in the ranking table, is 195%, being 1,6% points above the market average of 194%.
