

#### Moser GmbH Co KG Rank 52 of 116

The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Work In Progress Unfinished Goods Remainder, increasing the Economic Capital Ratio by 131% points. The greatest weakness of Moser GmbH Co KG is the variable Work In Progress, reducing the Economic Capital Ratio by 1.027% points.

The company's Economic Capital Ratio, given in the ranking table, is 190%, being 3,6% points below the market average of 194%.
