

#### Cadolto Modulbau GmbH Rank 1 of 116

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 1.365% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Work In Progress Unfinished Goods Remainder, reducing the Economic Capital Ratio by 2.589% points.

The company's Economic Capital Ratio, given in the ranking table, is 1.473%, being 1.279% points above the market average of 194%.
