

Markgraf Familien GmbH Konzern Rank 75 of 116

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Liabilities Of Which Due Within 1 Year Remainder, reducing the Economic Capital Ratio by 85% points.

The company's Economic Capital Ratio, given in the ranking table, is 167%, being 27% points below the market average of 194%.
