

The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 121% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Liabilities To Banks Remainder, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is 150%, being 42% points below the market average of 192%.
