

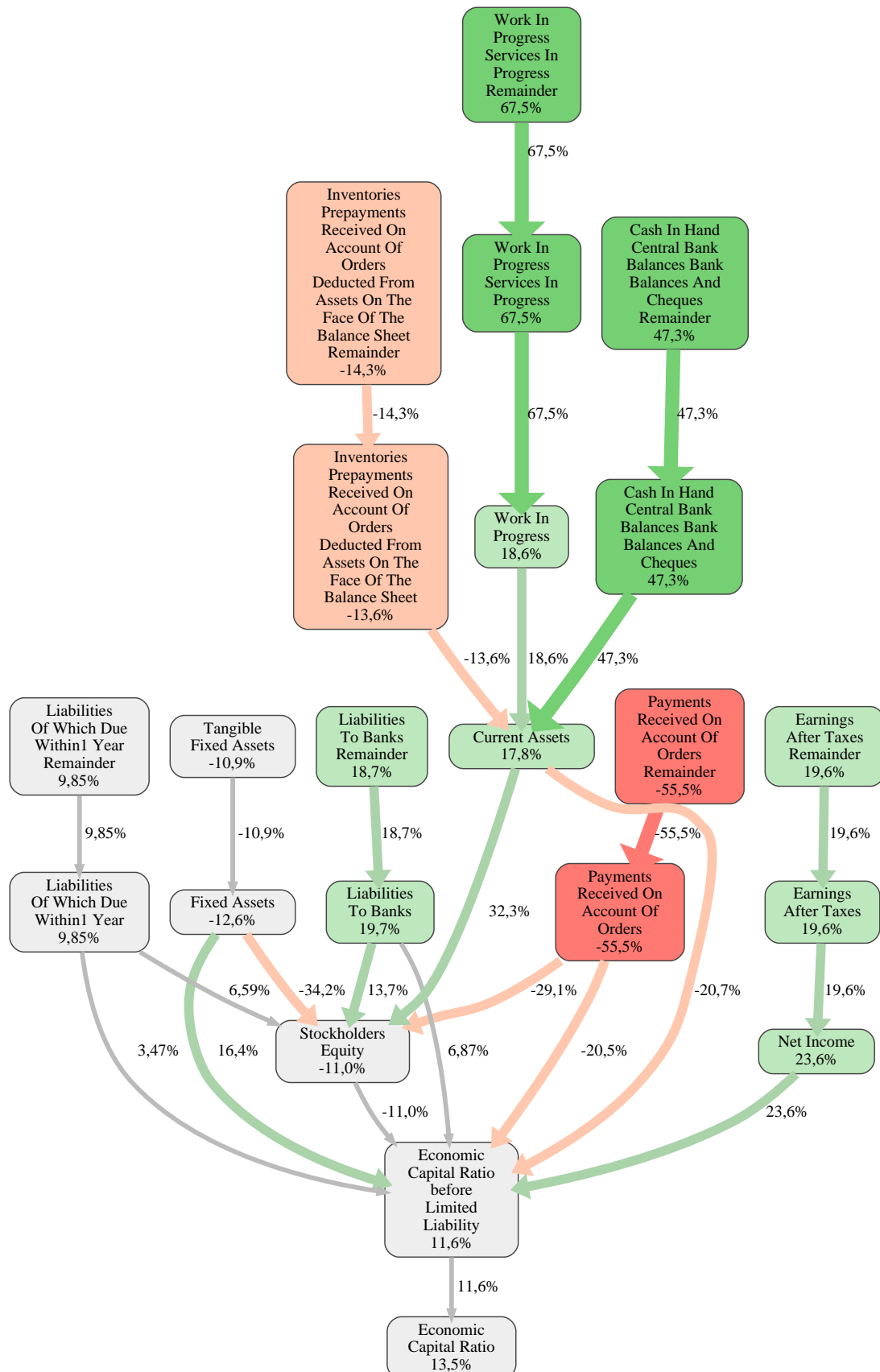

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Work In Progress Services In Progress Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Bateg GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 56% points.

The company's Economic Capital Ratio, given in the ranking table, is 206%, being 13% points above the market average of 192%.
