

VSTR AG Rodewisch Rank 38 of 116

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of VSTR AG Rodewisch is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 23% points.

The company's Economic Capital Ratio, given in the ranking table, is 210%, being 18% points above the market average of 192%.
