

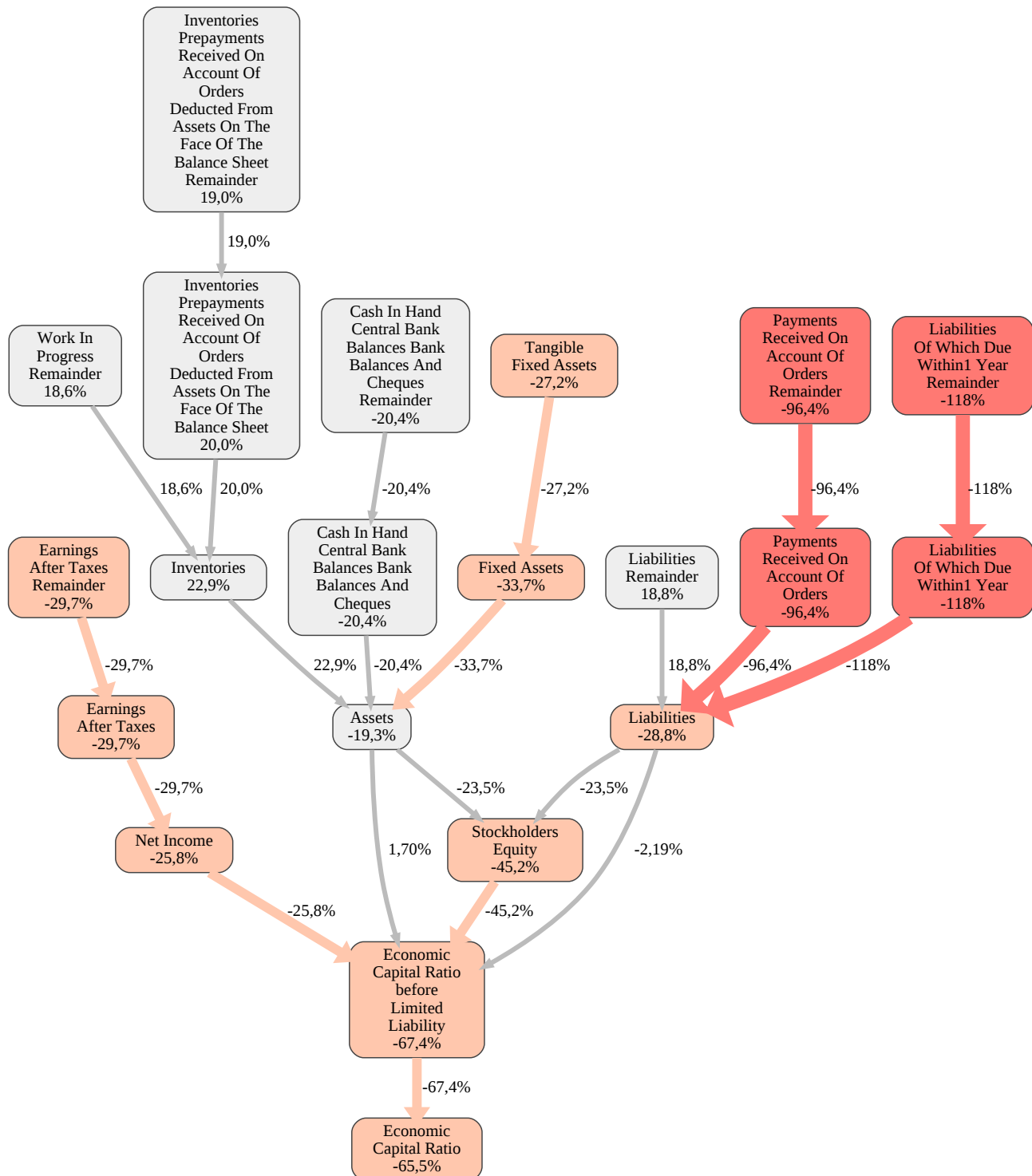

The relative strengths and weaknesses of Bauunternehmung Peter Igl GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 23% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Liabilities Of Which Due Within 1 Year Remainder, reducing the Economic Capital Ratio by 118% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 66% points below the market average of 192%.
