



The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 31% points. The greatest weakness of Rensch Haus GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 23% points.

The company's Economic Capital Ratio, given in the ranking table, is 245%, being 53% points above the market average of 192%.
