

Hanova Gewerbe GmbH Rank 98 of 116

The relative strengths and weaknesses of Hanova Gewerbe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Land Land Rights And Buildings Including Buildings On Third Party Land Remainder, increasing the Economic Capital Ratio by 37% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Liabilities To Banks Of Which Due After More Than 1 Year Remainder, reducing the Economic Capital Ratio by 119% points.

The company's Economic Capital Ratio, given in the ranking table, is 144%, being 48% points below the market average of 192%.
