

Hanova Services GmbH Rank 103 of 116

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Technical Equipment And Machinery Remainder, increasing the Economic Capital Ratio by 41% points. The greatest weakness of Hanova Services GmbH is the variable Liabilities Of Which Due Within1 Year Remainder, reducing the Economic Capital Ratio by 88% points.

The company's Economic Capital Ratio, given in the ranking table, is 135%, being 57% points below the market average of 192%.
