

## Markgraf Familien GmbH Konzern Rank 70 of 116

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Work In Progress Unfinished Goods Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 182%, being 9,9% points below the market average of 192%.
