

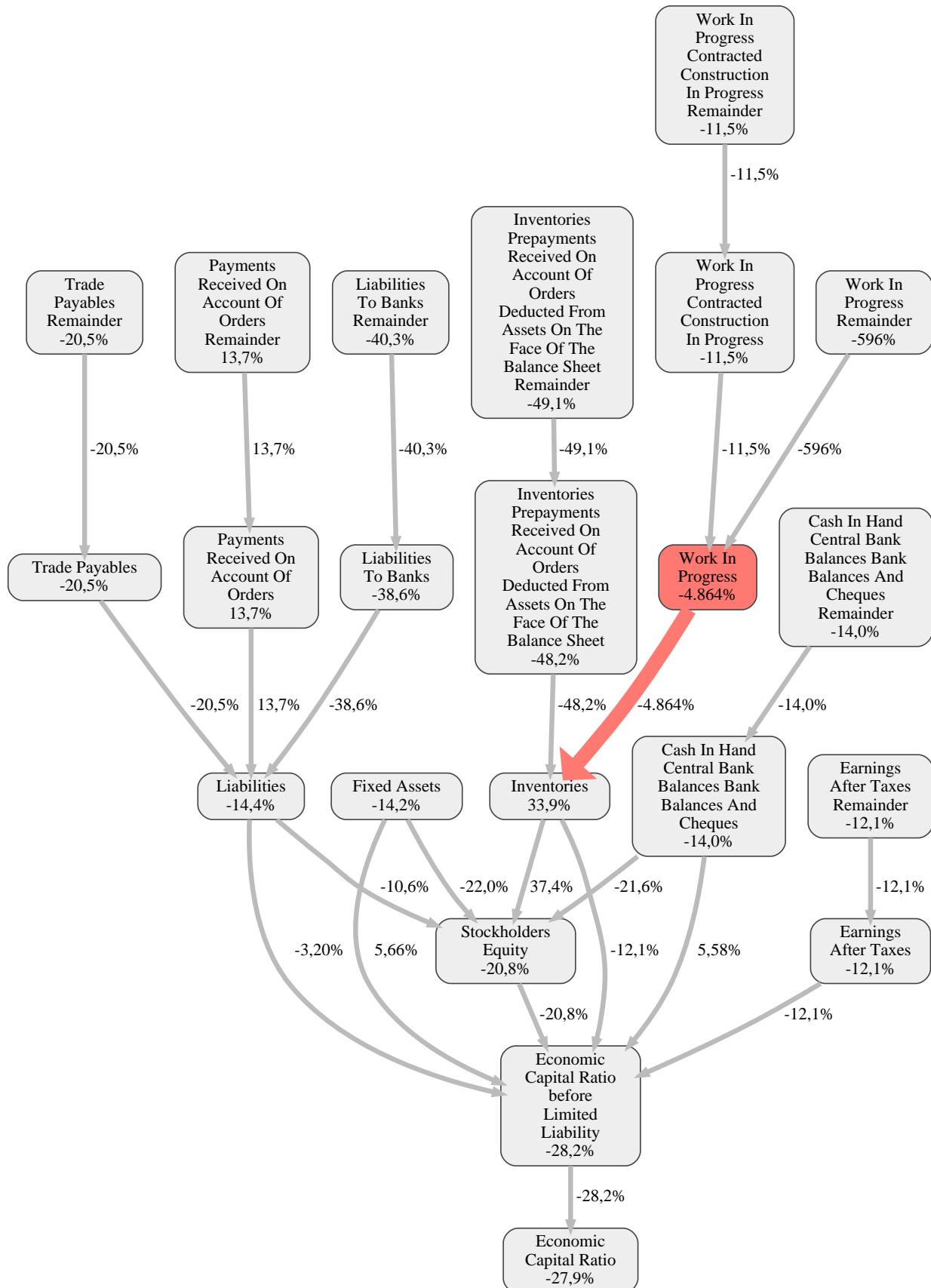

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 34% points. The greatest weakness of BMS Industriebau GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 4.864% points.

The company's Economic Capital Ratio, given in the ranking table, is 163%, being 28% points below the market average of 190%.
