

Sander Massivhaus GmbH Rank 111 of 113

The relative strengths and weaknesses of Sander Massivhaus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sander Massivhaus GmbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 18% points. The greatest weakness of Sander Massivhaus GmbH is the variable Liabilities Of Which Due After More Than 1 Year Remainder, reducing the Economic Capital Ratio by 59% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 79% points below the market average of 190%.
