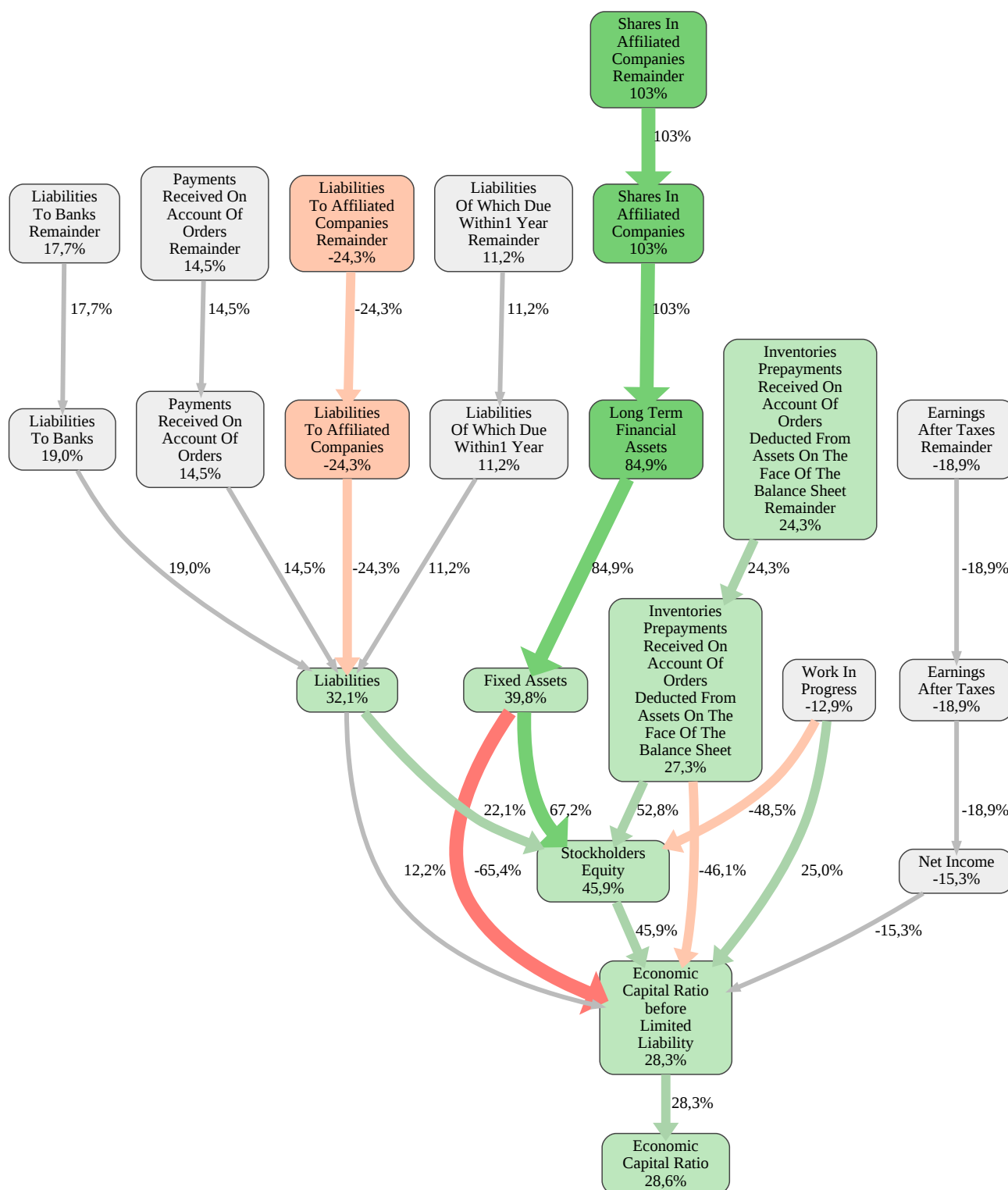




The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Shares In Affiliated Companies Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Liabilities To Affiliated Companies Remainder, reducing the Economic Capital Ratio by 24% points.

The company's Economic Capital Ratio, given in the ranking table, is 219%, being 29% points above the market average of 190%.
