

### Wadle Bauunternehmung GmbH Rank 95 of 113

The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Work In Progress Contracted Construction In Progress Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Liabilities To Affiliated Companies Remainder, reducing the Economic Capital Ratio by 41% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 50% points below the market average of 190%.
