



The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Other Taxes Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is 249%, being 58% points above the market average of 190%.
