

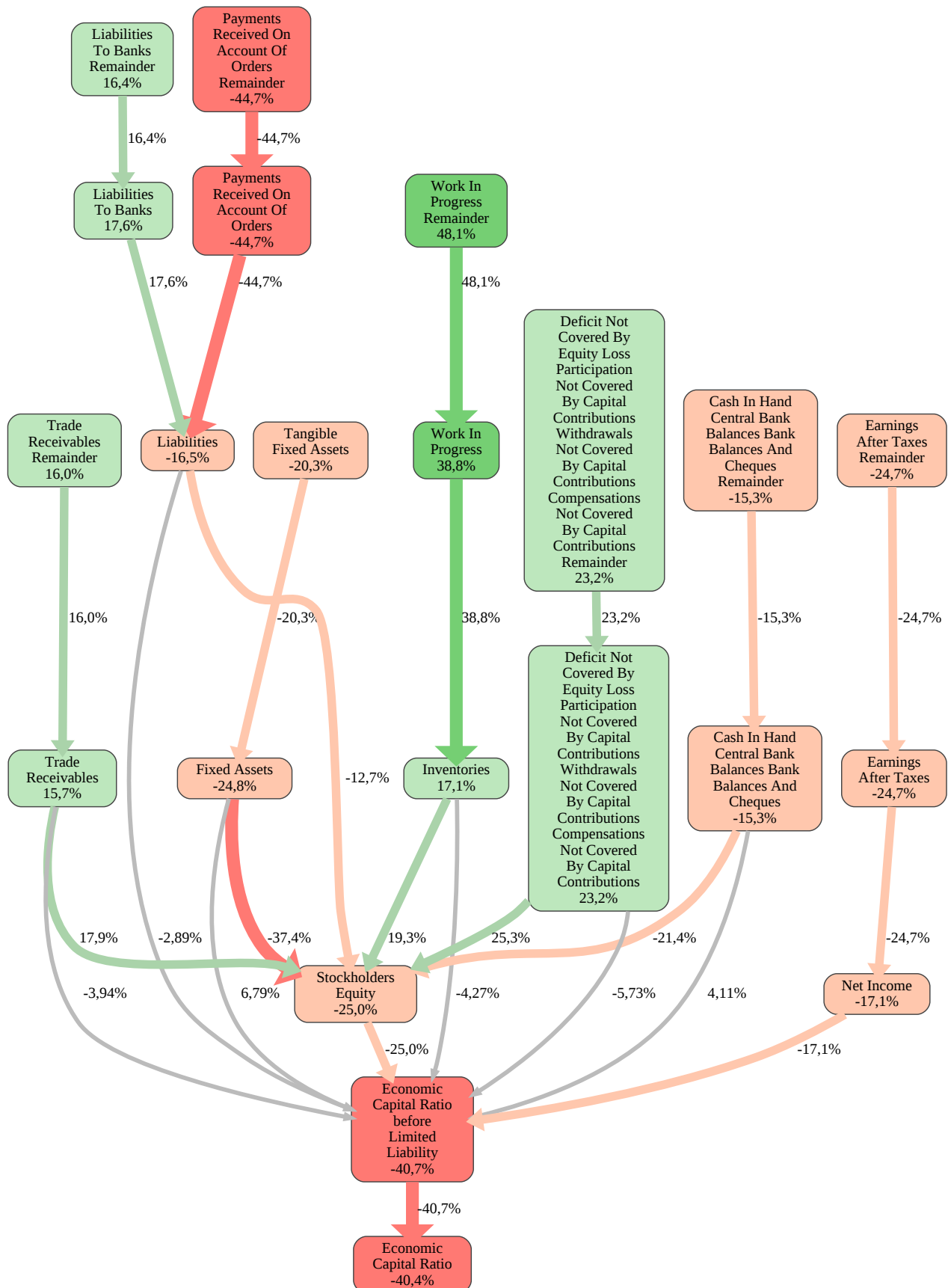

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Work In Progress Remainder, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Payments Received On Account Of Orders Remainder, reducing the Economic Capital Ratio by 45% points.

The company's Economic Capital Ratio, given in the ranking table, is 150%, being 40% points below the market average of 190%.
