

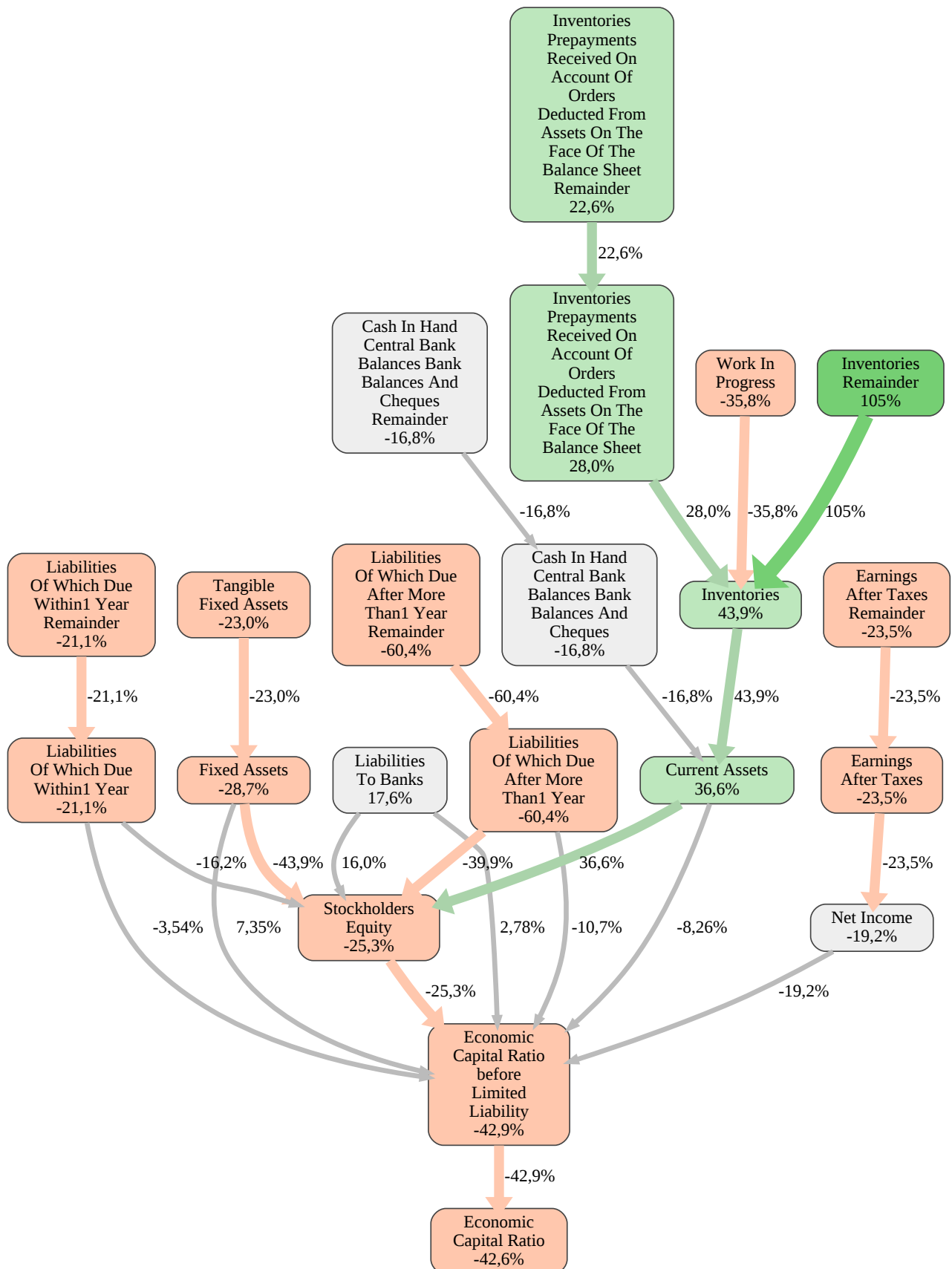

The relative strengths and weaknesses of Monte Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Monte Hochbau GmbH is the variable Liabilities Of Which Due After More Than 1 Year Remainder, reducing the Economic Capital Ratio by 60% points.

The company's Economic Capital Ratio, given in the ranking table, is 148%, being 43% points below the market average of 190%.
