

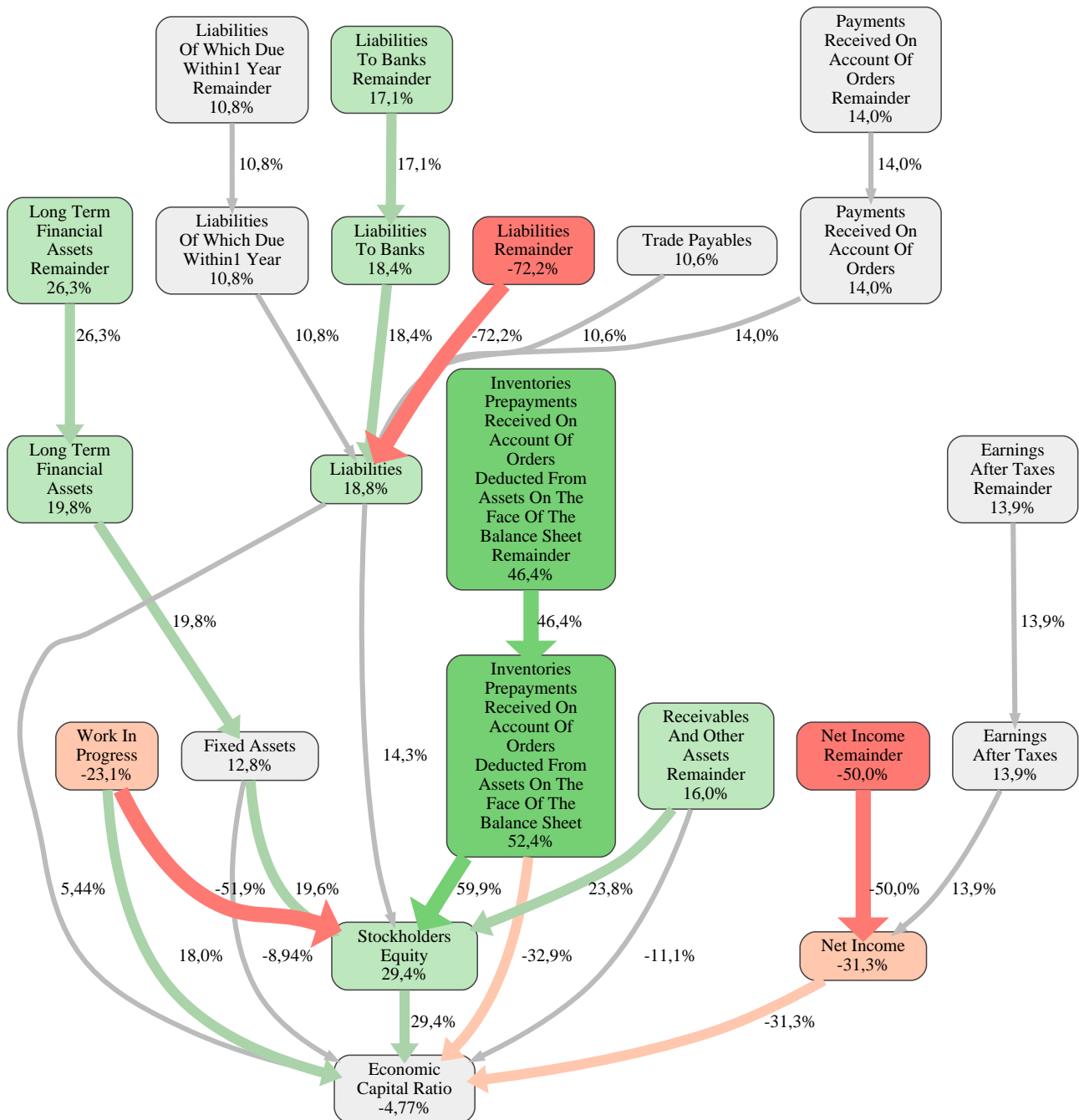

The relative strengths and weaknesses of Goldbeck GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH Konzern compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Goldbeck GmbH Konzern is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 72% points.

The company's Economic Capital Ratio, given in the ranking table, is 186%, being 4,8% points below the market average of 190%.
