

Bateg GmbH Rank 12 of 109

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Earnings After Taxes Remainder, increasing the Economic Capital Ratio by 44% points. The greatest weakness of Bateg GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 147% points.

The company's Economic Capital Ratio, given in the ranking table, is 254%, being 105% points below the market average of 359%.
