

#### Krüger Bau Bernau GmbH Rank 93 of 109

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Net Income, reducing the Economic Capital Ratio by 143% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 219% points below the market average of 359%.
