The relative strengths and weaknesses of Knobel BAU GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Knobel BAU GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 46% points. The greatest weakness of Knobel BAU GmbH is the variable Net Income, reducing the Economic Capital Ratio by 121% points.

The company's Economic Capital Ratio, given in the ranking table, is 212%, being 147% points below the market average of 359%.
