

Arning Bauunternehmung

The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 38% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 130% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 125% points below the market average of 359%.
