

Schrobsdorff Holding

The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 17.331% points. The greatest weakness of Schrobsdorff Holding AG is the variable Long Term Financial Assets Remainder, reducing the Economic Capital Ratio by 16.352% points.

The company's Economic Capital Ratio, given in the ranking table, is 17.740%, being 17.381% points above the market average of 359%.
