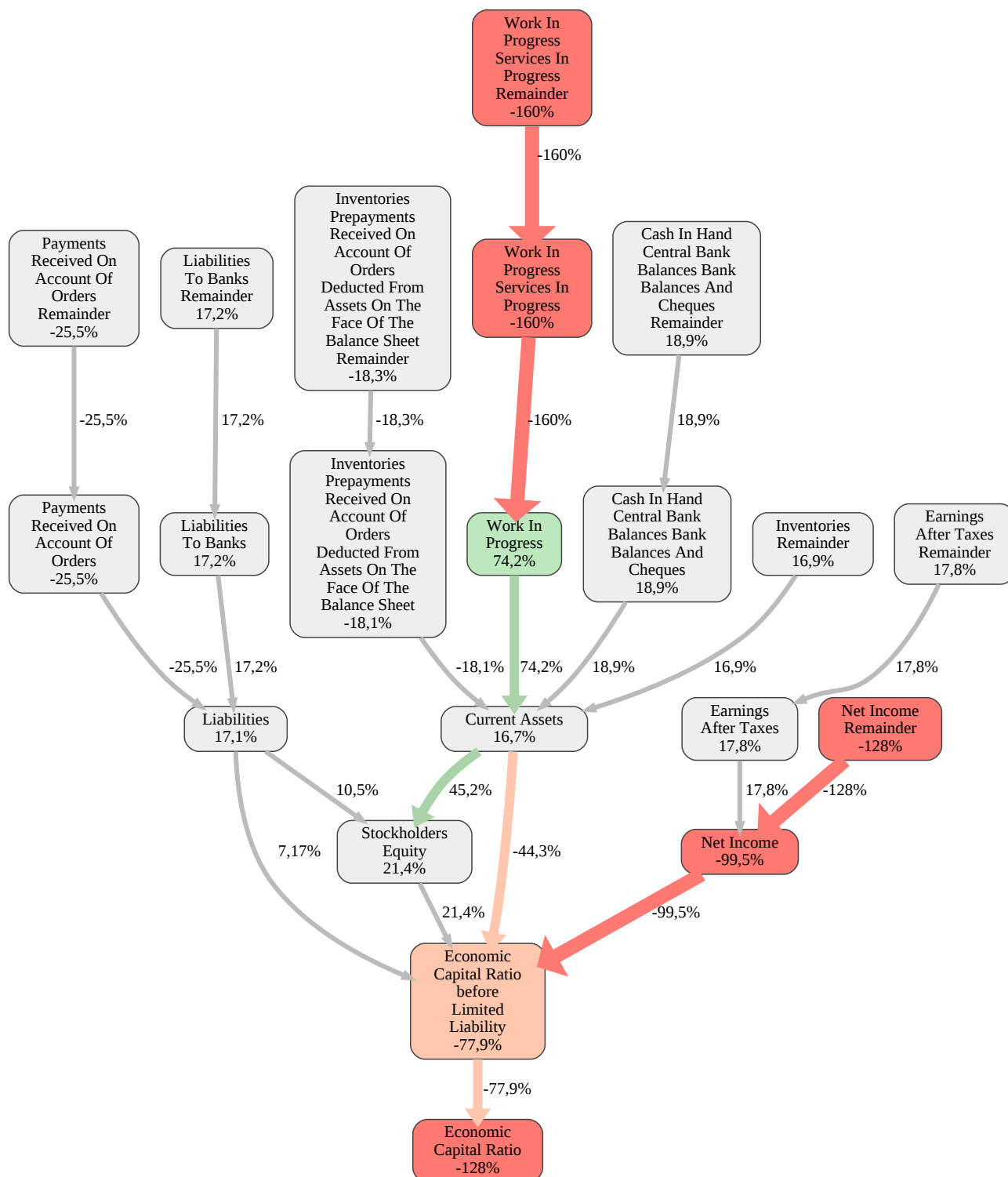




The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Schmeing Bau GmbH is the variable Work In Progress Services In Progress Remainder, reducing the Economic Capital Ratio by 160% points.

The company's Economic Capital Ratio, given in the ranking table, is 231%, being 128% points below the market average of 359%.
