

Wolf System GmbH Rank 33 of 109

The relative strengths and weaknesses of Wolf System GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wolf System GmbH compared to the market average is the variable Work In Progress Services In Progress Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Wolf System GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 144% points.

The company's Economic Capital Ratio, given in the ranking table, is 212%, being 147% points below the market average of 359%.
