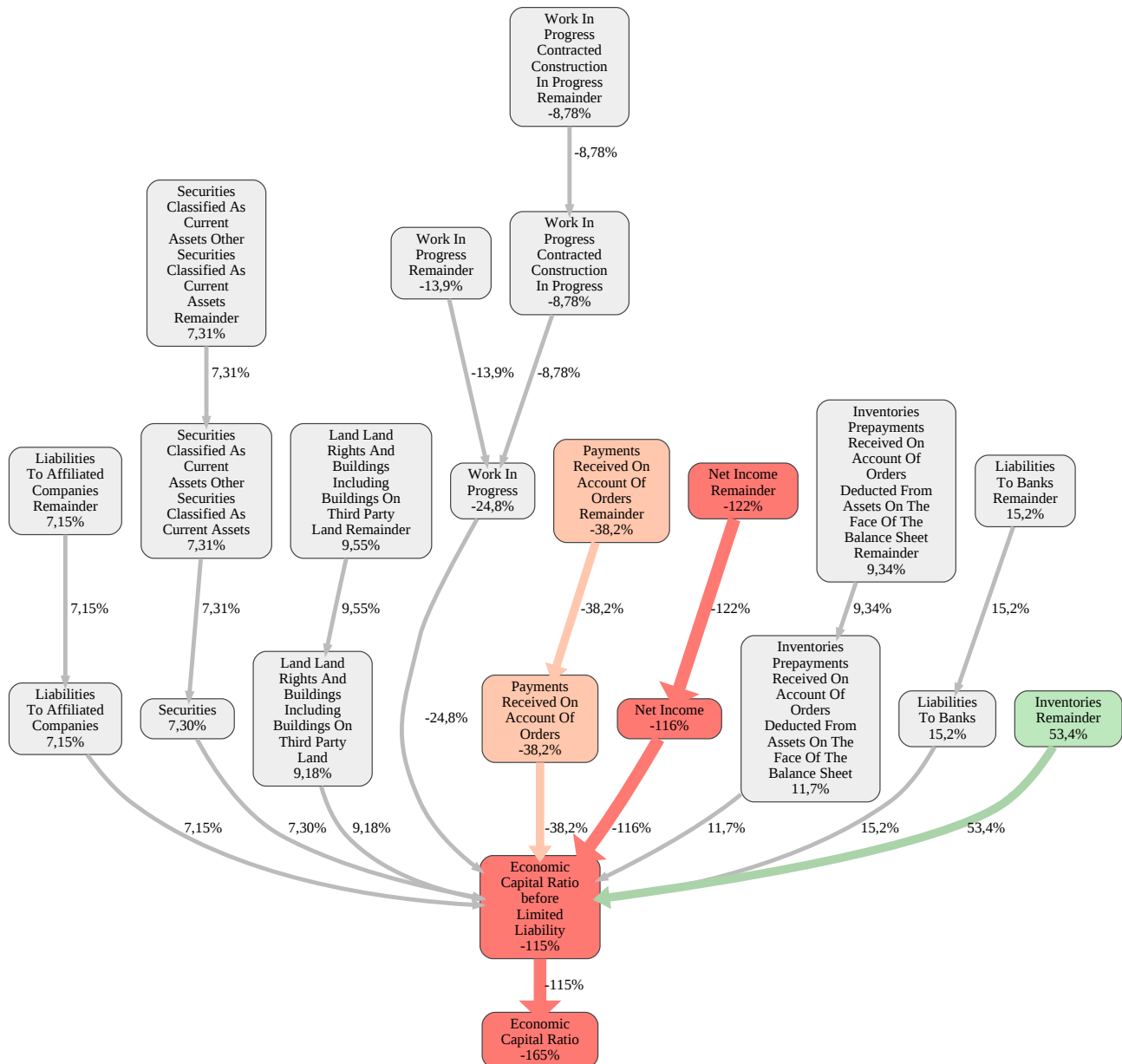




The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 53% points. The greatest weakness of Rensch Haus GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 122% points.

The company's Economic Capital Ratio, given in the ranking table, is 194%, being 165% points below the market average of 359%.
