

#### Bonava Wohnbau GmbH Rank 107 of 109

The relative strengths and weaknesses of Bonava Wohnbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Net Income, reducing the Economic Capital Ratio by 151% points.

The company's Economic Capital Ratio, given in the ranking table, is 113%, being 247% points below the market average of 359%.
