

Dreßler Bau

The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 31% points. The greatest weakness of Dreßler Bau GmbH is the variable Inventories Remainder, reducing the Economic Capital Ratio by 748% points.

The company's Economic Capital Ratio, given in the ranking table, is 227%, being 27% points above the market average of 200%.
