

Peter Ahrens Bauunternehmen GmbH Rank 31 of 43

The relative strengths and weaknesses of Peter Ahrens Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques Remainder, increasing the Economic Capital Ratio by 43% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 2.652% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 46% points below the market average of 200%.
