

## Gulfslope Energy INC Rank 92 of 102

The relative strengths and weaknesses of Gulfslope Energy INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gulfslope Energy INC compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 9.1% points. The greatest weakness of Gulfslope Energy INC is the variable Liabilities, Current, reducing the Economic Capital Ratio by 80% points.

The company's Economic Capital Ratio, given in the ranking table, is 9.1%, being 94% points below the market average of 103%.
