

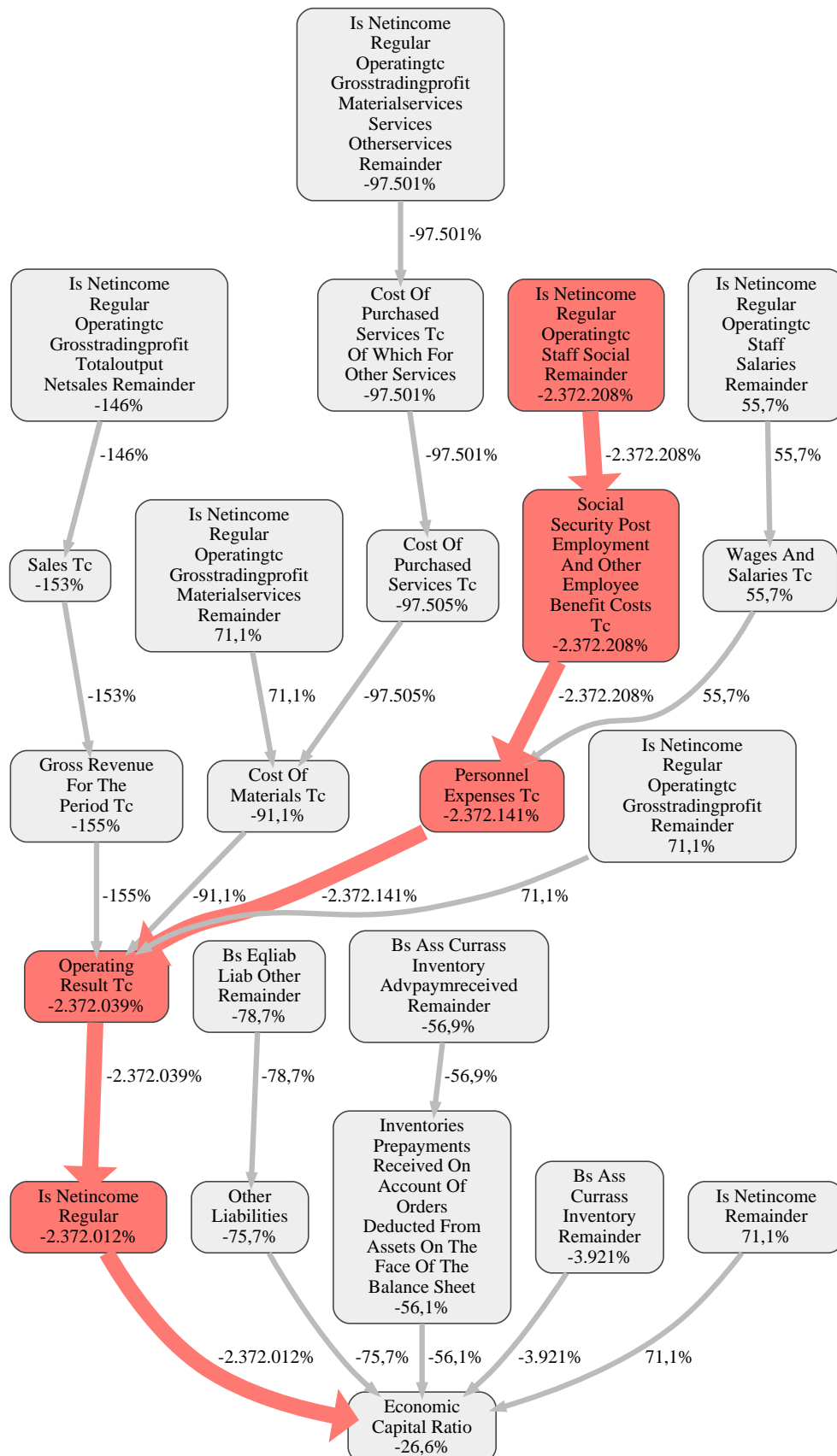

The relative strengths and weaknesses of Himmel u Papesch Bauunternehmung GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Himmel u Papesch Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Himmel u Papesch Bauunternehmung GmbH Co KG is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.208% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 27% points below the market average of 98%.
