



The relative strengths and weaknesses of B O Bau und Gebäudetechnik GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bau und Gebäudetechnik GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 132% points. The greatest weakness of B O Bau und Gebäudetechnik GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.466% points.

The company's Economic Capital Ratio, given in the ranking table, is 132%, being 34% points above the market average of 98%.
