



The relative strengths and weaknesses of Mayerhofer Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 144% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.244% points.

The company's Economic Capital Ratio, given in the ranking table, is 144%, being 46% points above the market average of 98%.
