



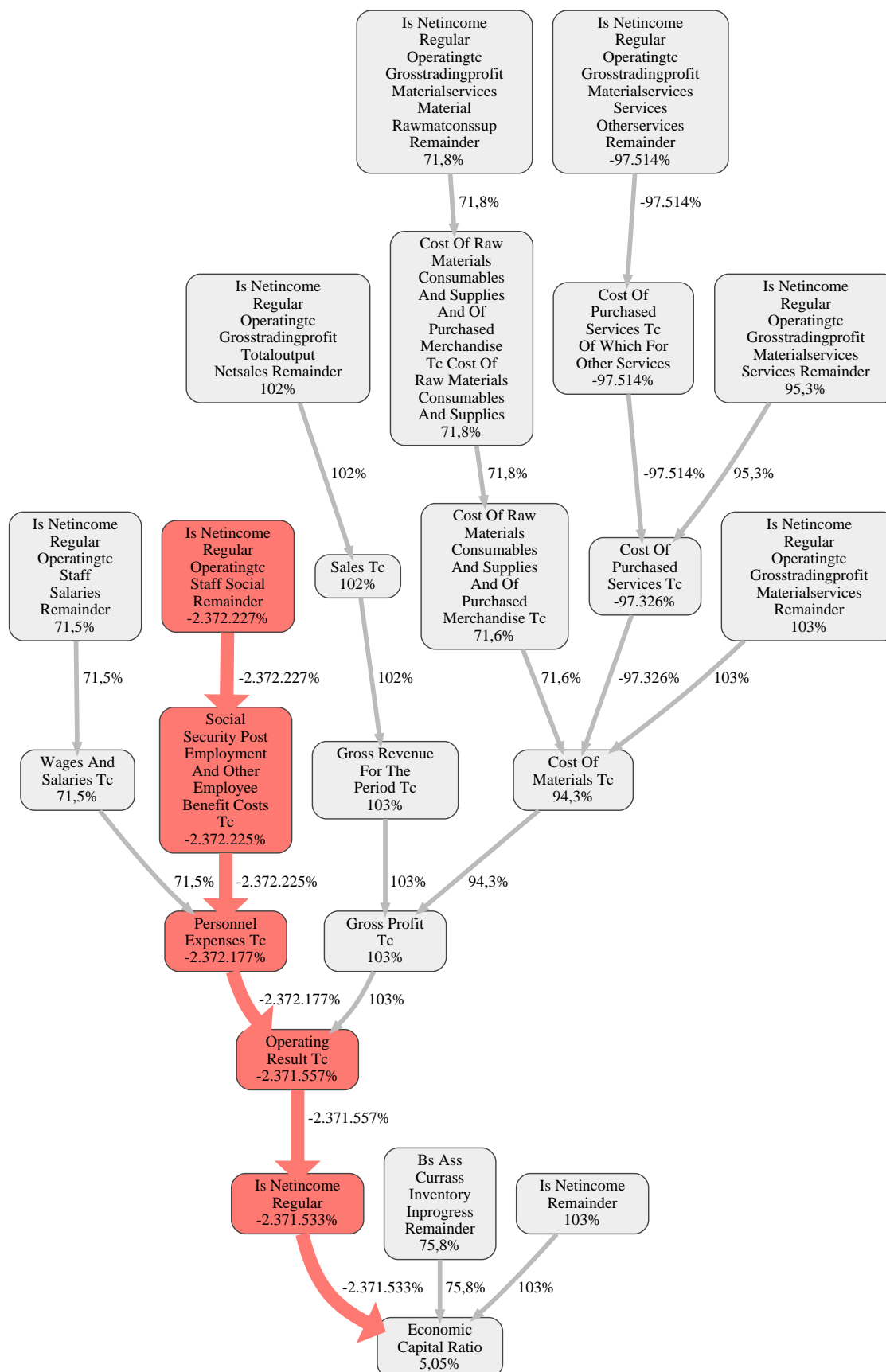

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Staff Social Remainder, reducing the Economic Capital Ratio by 2.372.227% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 5,1% points above the market average of 98%.
