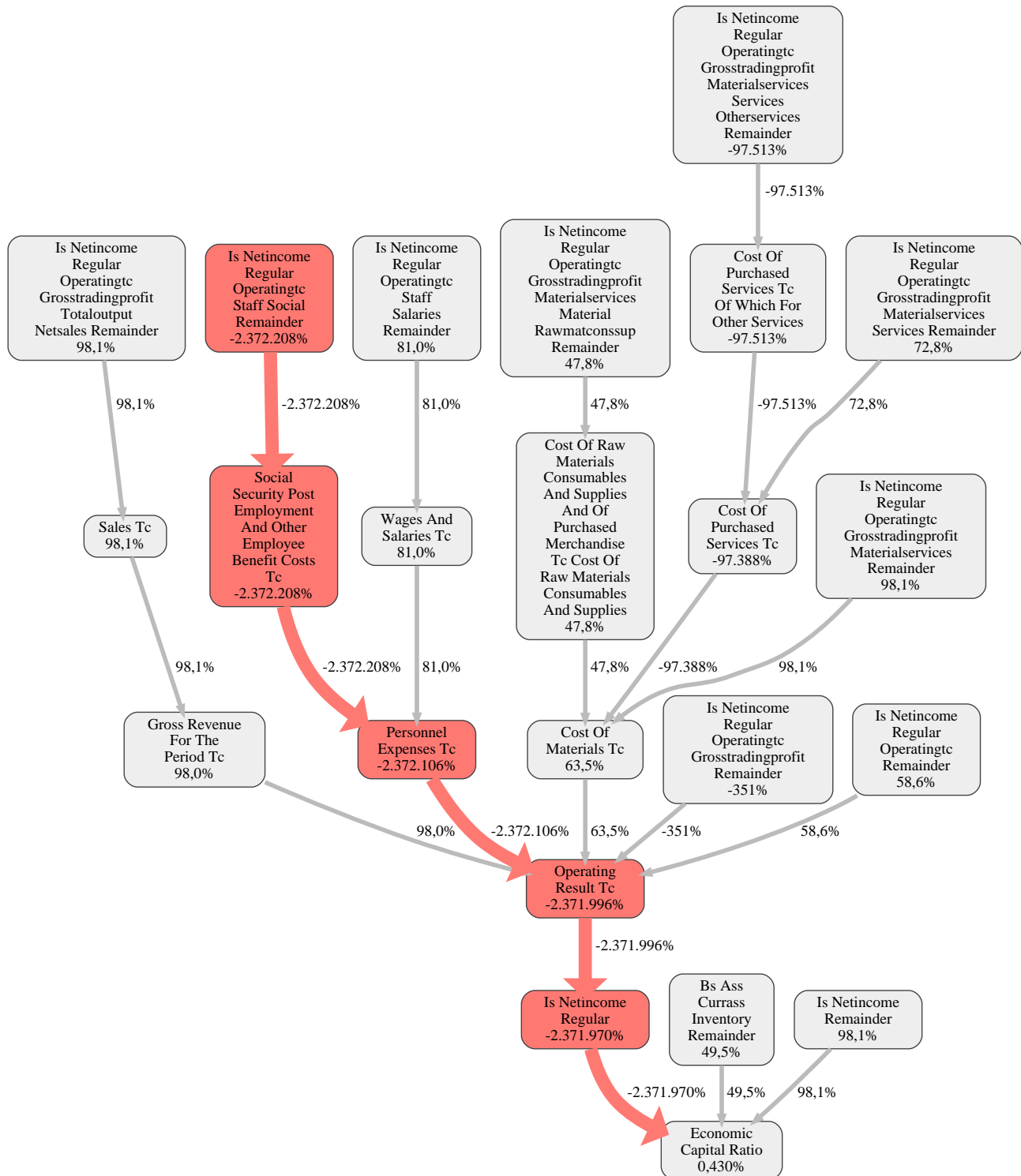

The relative strengths and weaknesses of Sax Klee GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sax Klee GmbH Bauunternehmung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Sax Klee GmbH Bauunternehmung is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.208% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 0,43% points above the market average of 98%.
