

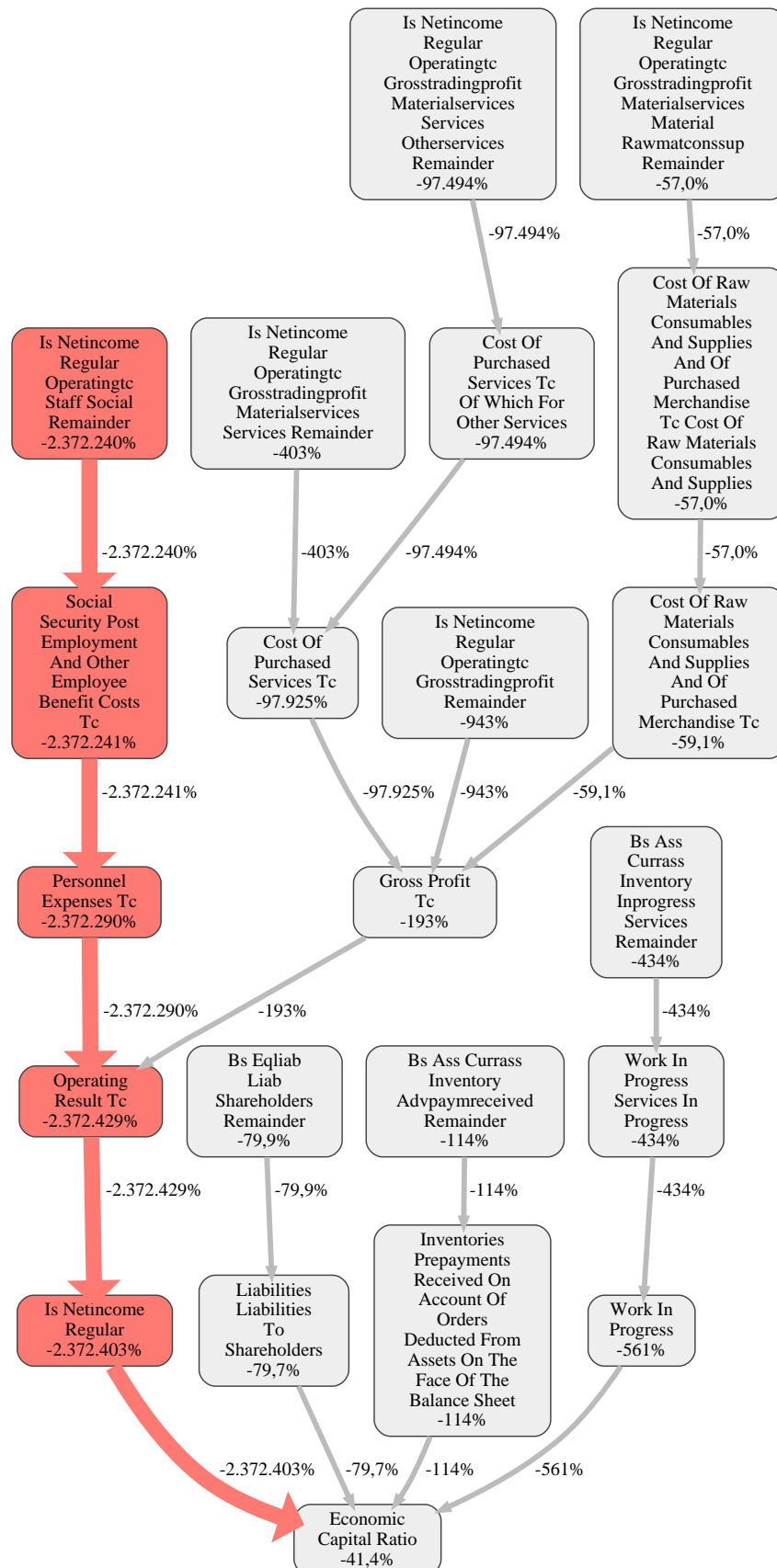

The relative strengths and weaknesses of Brunner Co Baugesellschaft mbH Co München are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Brunner Co Baugesellschaft mbH Co München compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Brunner Co Baugesellschaft mbH Co München is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.429% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 41% points below the market average of 98%.
