



The relative strengths and weaknesses of Lim Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.232% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 46% points below the market average of 98%.
