



The relative strengths and weaknesses of Wolf System GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wolf System GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 145% points. The greatest weakness of Wolf System GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.493% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 47% points above the market average of 98%.
