



The relative strengths and weaknesses of Hentschke Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hentschke Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 139% points. The greatest weakness of Hentschke Bau GmbH is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.295% points.

The company's Economic Capital Ratio, given in the ranking table, is 139%, being 41% points above the market average of 98%.
