The greatest weakness of Faber Schnepf Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Regular Operatingtc Staff Social Remainder, reducing the Economic Capital Ratio by 2.372.241% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 4,2% points below the market average of 98%.
