



The relative strengths and weaknesses of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.496% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 29% points below the market average of 98%.
